I understand physical mistreatment conflicts with the Constitution of the Most Worshipful Union Grand Lodge, and By-Laws of \_\_\_\_\_ Lodge No. \_\_\_\_\_. I also agree to hold and save harmless, and indemnify, the Most Worshipful Union Grand Lodge against any and all liability, loss, expense and damages of whatsoever kind of nature, which the Most Worshipful Union Grand Lodge sustains or incurs as a proximate result of such mistreatment, including but not limited to attorney's fees and costs, in which I participate. I understand that I am not waiving any rights I may have against any individual for any damages I may sustain as a result of physical mistreatment. I understand that I will not be penalized nor disciplined by my Lodge or the Most Worshipful Union Grand Lodge by having reported an incident(s) of mistreatment, as required by this agreement. If after investigation and confirmation by the Most Worshipful Union Grand Lodge that mistreatment has in fact occurred, I understand that those individual(s) involved in the mistreatment may be disciplined by the Lodge and/or the Most Worshipful Union Grand Lodge. I further certify that I have read, understand and agree to the terms and conditions of this agreement, and I have received a copy of the same bearing my signature. I agree that this agreement shall be binding and effective against my heirs and successors.
